

It was argued on behalf of the government that it must be presumed that Congress in passing the Philippine act must have been familiar with and had in mind the local laws in the Philippines and the judicial construction which they had received at the hands of the Supreme Court of the Islands and that Congress legislated with special reference thereto. On the other hand it was contended that the statute should receive the same interpretation it had always been given by the English and American Courts. The latter contention prevailed and the Court by a vote of five to four decided that the principle should have application as it is in this country, thus denying the government the right to appeal from judgments of acquittal in criminal cases. Your Mr. Justice Day wrote the opinion in this case also. Simultaneously with the reform in the law of procedure, the Commission established the judiciary proper, consisting of the Supreme Court, the Courts of First Instance, the Bureau of Justice, and the Justices of the Peace. The personnel of this judiciary typifies the whole Philippine public service. It comprises both Filipinos and Americans, and the American portion of it is composed of Democrats and Republicans. From the beginning the Commission adoptedjthe policy of appointing Filipinos to office wherever competent ones could be found and of selecting Americans without regard...
